ROOTED IN THE COMMUNITY

Dear Lincoln Champions,

I've been thinking a lot about the power of community as I settle into my role as CEO of Lincoln. We live in a time for many of division, isolation, and a loss of connection that provides meaning and a sense of belonging. At the same time, we see stories of hope every day in the communities we serve that sustain and inspire us, that bring to life neighbors helping neighbors, and that show the power of community to bring us together.

We have always been deeply rooted in the communities we serve. We know that individuals and families understand the strengths and needs of their neighborhoods better than anyone. We know the importance of creating a strong ecosystem in which schools, nonprofits, businesses, individuals, and families work together to nourish connections and resources, and improve outcomes for youth and families. This report looks back at the last year and provides an inspiring snapshot of the ways Lincoln is rooted in the communities we serve through our many school- and community-based services; a few are highlighted below.

As always, we put youth and families first. We put youth and families first in West Oakland where we opened our new Mandela Family Resource Center this fall. We've seen the power of Family Resource Centers for creating community and change and generating sustainable support networks for families at our school-based center in East Oakland. Now West Oakland families have their own space to drop in and break bread, discuss concerns and share successes, and get supports that enhance their lives.

We put youth and families first at Park Middle School in Antioch, where the creation of a new Lincoln Community School Coordinator position was made possible through robust county and district partnerships. We know that strong families produce happy, health, and thriving children and that family engagement is one of the greatest indicators for student achievement. Our new Coordinator has already begun bringing together resources to create new pathways for families and increasing school-wide capacity for sustaining them.

We put youth and families first in Hayward where our Kinship program provides relative caregivers with a unique combination of crucial benefits, resources, and group supports to ensure youth thrive and become successful

adults. We have also spent the summer convening caregiver focus groups to identify their unique needs and inform policy work to improve service delivery and improved quality of life outcomes.



WHAT'S AHEAD

Over the past 136 years, Lincoln has expanded and evolved to meet the needs of the communities we serve.

We dig our roots a little deeper each year to tackle the most difficult barriers facing youth and families: educational inequities, economic disparities, and limited access to mental health and wellness services. We are far from done.

We remain in the forefront of the battle to eradicate poverty, heal trauma, and ensure equitable opportunities for all children and families to reach their full potential. This year, as we implement the year-two priorities of our new Strategic Plan, we will continue to innovate our services and advocacy work to lift up, make visible, and address the challenges that children and families face on their journey towards building strong futures.

We have been actively campaigning and advocating for ten state bills during the 2019 legislative session, and tracking an additional 51 bills around issues such as defining state statute for family resource centers and updating the Foster Youth Bill of Rights. This November, we will hold an inaugural Kinship Policy Summit to bring together a diverse group of experts committed to child safety and launch a statewide kinship families campaign to bring this important missing voice to the Capitol.

We're excited for what's ahead and look forward to providing even more youth and families opportunities for realizing a positive, productive, and equitable future.




